The Board of Township Trustees of St. Albans Township, Licking County, Ohio, met in regular session on the 13th day of December, 2022 with the following members present:

RESOLUTION

WHEREAS, the Staffing for Adequate Fire and Emergency Response Grants (SAFER) was created to provide funding directly to fire departments and volunteer firefighter interest organizations to help them increase or maintain the number of trained, "front line" firefighters available in their communities; and,

WHEREAS, the goal of SAFER is to enhance the local fire departments' abilities to comply with staffing, response and operational standards established by the NFPA (NFPA 1710 and/or NFPA 1720); and,

WHEREAS, the Board of Trustees of St. Albans Township, Licking County, Ohio was awarded a SAFER grant to hire three (3) additional firefighters in September 2022; and,

WHEREAS, the SAFER grant amount is \$1,144,524 and the grant period is three (3) years; and,

WHEREAS, the Fire Department Chief has offered employment to three individuals who will begin working as Firefighter beginning January 1, 2023; and,

WHEREAS, future employees of the Township shall be aware and agree to the project description, compensation, benefits and other details of their employment; and,

NOW, THEREFORE, BE IT RESOLVED: that the Board of Trustees of St. Albans Township, Licking County, Ohio,

BE IT FURTHER RESOLVED: that the Board of Trustees of St. Albans Township, Licking County, Ohio hereby adopts the Firefighter Position Profile (attached as Exhibit A).

BE IT FURTHER RESOLVED: that this Board hereby authorizes the effective date of the Firefighter Position Profile to be December 14, 2022 and effective until otherwise amended by the Board.

BE IT FURTHER RESOLVED: that it is hereby certified that all formal actions of the Board of Trustees of St. Albans Township, Licking County, Ohio relating to the adoption of this Resolution were taken in an open meeting of the Board and that all deliberations of the Board were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

BE IT FURTHER RESOLVED: that this Resolution shall take effect and be enforced from and after the earliest period allowed by law.


